Trafalgar Tours x MasterChef Competition

Terms and Conditions

1. Information on how to enter forms part of the terms of entry. Entry into the “Trafalgar Tours x MasterChef Competition” (“**Competition**”) is deemed acceptance of these terms and conditions.

Eligibility to Enter

2. Entry is open to all residents of Australia, 18 years and older. However, employees and the immediate families of Network Ten Pty Limited (the “**Promoter**”), Trafalgar Tours (Aust.) Pty Ltd (the “**Sponsor**”) and their associated agencies and companies or any organisation or individual associated with the provision of the prize are not eligible to enter the Competition. Entrants must be residing in Australia at the time of entry, or their entry may be deemed invalid.

Competition Period

3. The competition commences on **Sunday, 19 April 2026 at 00:00 AEST** and closes on **Friday, 14 August 2026 at 00:00 AEST** (“**Competition Period**”).
4. The Competition will be advertised on, but not limited to, Network 10 and www.10.com.au.

How to Enter

5. To participate in the Competition entrants must either:
 - a. Log on to 10.com.au/win and register their details on the competition page. Details to enter the competition include first name, last name, email address, phone number, postcode, month and year of birth, or;
 - b. Become a 10 member. Specific details include first name, last name, post code, phone number, email address, gender, month and year of birth and favourite genre to become a 10 member.
6. It is free to become a 10 member, however, the cost of accessing the promotional website is dependent on the entrant’s individual service provider. These Terms and Conditions apply in conjunction with the 10 Members rules.
7. Incomprehensible and incomplete entries will be deemed invalid.
8. Entrants who have won a Major Prize in any Network 10 competition in the past 12 months are not eligible to win a prize in this competition, excluding entrants who reside in South Australia who are eligible to win more than once.

It is the account holder’s sole responsibility to control any and all access to their device. The Promoter, the Sponsor, and Ansible Pty Ltd who has been appointed by the Promoter to be the Competition administrator (“**Ansible**”), will not be responsible for any loss, damage or costs incurred as a result of failure to comply with this or as a result of technical or telecommunications problems, including security breaches. Entrants must not use another’s device without express permission from the account holder.
13. The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant’s identity, age, and place of residence) and to disqualify any entrant who submits an entry that is not in accordance with these Terms and Conditions or who tampers with the entry process. Error and omissions will be accepted at the Promoter’s discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
14. In consideration for the Promoter awarding the prize to the winner of the Competition (“**Prize Winner**”), the winner hereby permits their image and/or voice, as recorded, photographed, or filmed during the winner participation in the prize to appear in connection with Network 10 or the Sponsor or the advertising and/or marketing thereof, in any media whatsoever through the world and the Prize Winner will not be entitled to any fee for such use.

16. Ansible Pty Ltd will notify the Prize Winner by a phone call and in writing via email within two (2) days of the draw and the Prize Winner’s details (last name, first initial and postcode) will be published on the 10 website at 10.com.au/win from Wednesday, 19 August 2026.
17. An entry that is made on behalf of an entrant by a third party will be invalid.
18. If required, an unclaimed prize draw will take place at Ansible, Level 3, 100 Chalmers Street, Surry Hills NSW 2010 on **Monday, 9 November 2026 at 10:00 AEDT**. The unclaimed prize winner will be notified of their prize by phone call and in writing via email and their details (last name, first initial and postcode) within two (2) days of the Unclaimed Prize Draw and will be published on the 10 website at 10.com.au/win from Monday, 9 November 2026.

Prize Details

(the “Prize”).

20. The total prize pool is valued at **\$10,000.00** (including GST). The prize value is to be considered in its local currency (Australian dollars). The prize value is correct at time of publishing of these Terms and Conditions. The Promoter accepts no responsibility for change in prize value between now the ultimate prize redemption date.
21. Neither the Promoter or the Sponsor takes any responsibility for any tax consequences or imposts that arise from the receipt of the Prize. The Prize Winner is advised that tax implications may arise from winning the Prize and they should seek independent financial advice prior to acceptance of their Prize.
22. It is a condition of accepting the Prize that the Prize Winner must comply with all the conditions of use of the Prize.
23. It is a condition of accepting the Prize that the Prize Winner may be required to sign a legal release in a form determined by the Promoter in its absolute discretion.
24. The Prize consists of one (1) \$10,000 AUD Trafalgar Tour voucher to be used towards a Trafalgar tour for a maximum of two (2) people travelling to a destination of the winner’s choice. Tour includes accommodations per selected tour itinerary, meals per selected tour itinerary, and inclusions as per the tour package. All tours are subject to availability at time of booking. International flights are not included. Internal flights are included as specified in certain tour itineraries.
25. The Prize winner and their travel companion are responsible for obtaining proper travel documentation (e.g., passports, visas etc.), travel insurance, meals not included in selected tour itinerary, ground transportation, additional accommodation, international flights and all other costs, expenses and taxes that are not specifically included above. The Sponsor is not responsible if winner or their travel companion is denied entrance into any country for any reason. No changes are permitted to reservations once date of travel is confirmed, or ticket has been issued.
26. The trip must be booked and completed by 31 December 2027 and is subject to availability at the time of booking. Certain blackout periods may apply. If the trip has not been booked by 31 December 2027, the Winner will forfeit the prize in its entirety.
27. The winner will only be allowed to book one (1) tour. If the tour chosen is less than \$10,000 AUD, a cash value will not be given, and unused funds will be forfeited. If winner chooses a tour over \$10,000 AUD, the winner will be responsible for paying the difference of the trip prize at their own expense.
28. The prize, or any unused portion of the prize, is not exchangeable or cannot be redeemed for cash. The Prize cannot be used in conjunction with any other special offer. By accepting the Prize, the winner acknowledges that they have read, understood, and agree to be bound by the Sponsor's Terms to the extent they apply to the tour package subject of the Prize. The Sponsor may amend the Sponsor's Terms from time to time. In the event of any inconsistency between these Terms and Conditions and the Sponsor's Terms, these Terms and Conditions prevail to the extent of the inconsistency, except that operational matters relating to the booking, supply and delivery of the tour package subject of the Prize will be governed by the Sponsor's Terms. The winner's redemption and use of the Prize is contingent upon compliance with all requirements set out in the Sponsor's Terms, including any booking procedures, travel dates, identification requirements, conduct policies and other conditions of participation. Failure to comply with the Sponsor's Terms may result in forfeiture of the Prize. To the extent permitted by law, no cash or other alternatives will be offered.

General Terms

30. The Promoter's decision is final, and the Promoter will not enter into correspondence regarding the Competition result.
31. Personal information about a Prize Winner will be shared with any agents, to the extent necessary for the Prize to be delivered to the Prize Winner.
32. If the Prize Winner does not provide proof of meeting the age restriction and other valid entry requirements, the Prize will be forfeited in full, and the Prize Winner will have no further claim. A re-draw will be held to award the Prize to a valid entrant.
33. The Prize will be awarded to the person named in their contestant entry. Should an entrant's contact details change during the Competition Period it is the entrant's responsibility to notify the Promoter. A request to access or modify any information provided in an entry should be directed to the Promoter.
34. Should a Prize Winner not meet any of the criteria stated in these terms and conditions to be a valid Prize Winner they will forfeit all rights to the Prize, and a redraw will take place to reallocate the Prize to a valid Winner.
35. By accepting the Prize, the Prize Winner agrees to participate in and co-operate as required with all reasonable media editorial requests relating to the Prize, including but not limited to, being interviewed, and photographed, filmed and/or chaperoned throughout the duration of the Prize.
36. If for any reason this Competition is not capable of running as planned, including due to infection by computer virus, bugs, tampering, unauthorised intervention, fraud, technical failures or any causes beyond the control of the Promoter, which corrupt or affect the

administration, security, fairness or integrity or proper conduct of this promotion, the Promoter reserves the right in its sole discretion to disqualify any individual who tampers with the entry process, take any action that may be available, and to cancel, terminate, modify or suspend the Competition, subject to government legislation.

Method of validation (without limitation) will be determined by the Promoter at its complete discretion. Nothing in these Terms and Conditions limits, excludes, or modifies or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Competition and Consumer Act, as well as any other implied warranties under the ASIC Act or similar consumer protection laws in the State and Territories of Australia ("**Non-Excludable Guarantees**"). Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter and the Sponsor (including their respective officers, employees and agents) excludes all liability (including negligence), for any personal injury; or loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the promotion and: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any entry or prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoters) due to any reason beyond the reasonable control of the Promoter; (d) any variation in prize value to that stated in these Terms and Conditions; (e) any tax liability incurred by a Winner or entrant; or (f) use of the prize.

If this promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law: (a) to disqualify any entrant; or (b) subject to any written directions from a regulatory authority, to modify, suspend, terminate or cancel the promotion, as appropriate, subject to government legislation.
40. All entries become the property of the Promoter.
41. The Promoter shall not be liable for any loss or damage whatsoever which is suffered (including but not limited to indirect or consequential loss) or for any personal injury suffered or sustained in connection with any prize/s except for any liability which cannot be excluded by law. The Promoter is not responsible for any incorrect or inaccurate information, either caused by the phone user or for any of the equipment or programming associated with or utilised in this Competition, or for any technical error, or any combination thereof that may occur in the course of the administration of this Competition including any omission, interruption, deletion, defect, delay in operation or transmission, communications line or telephone, mobile or satellite network failure, theft or destruction or unauthorised access to or alteration of entries.
42. You consent to the Promoter collecting your personal information for the purpose of conducting and promoting this Competition (including but not limited to determining and notifying the Prize Winner and prize fulfilment). Your personal information may be disclosed to a third party as a result of entering this competition, including but not limited to the Sponsor and Ansible. Your personal information may be disclosed to State and Territory lottery departments and the Prize Winners' names published as required under the relevant lottery

legislation. For purposes of public statements and advertisements The Promoter will only publish the Prize Winner's surname, initial and State. A request to access, update or correct any information should be directed to the Promoter. If you are not willing for this to occur you cannot participate in the promotion.
